Scope of the call

- Joint R&D projects from Czech and Saxony
- to develop new products or processes
- to be focused on specific outcomes in the field of applied research
- Specific outcomes that will lead to attaining new findings and skills for development of new or significantly improved products, processes or services
- Saxon Partners will be fund by European Regional Development Fund -ERDF/JTF Technology Funding 2021-2027 (EFRE/JTF-Technologieförderung 2021-2027)

What

Topic of the call

- *Smart, safe, sustainable and resilient mobility and transport for passengers and goods*

Priority areas of research:

- *Connected, cooperative and automated mobility (CCAM) technologies and systems*
- *Physical and digital infrastructures assisting CCAM*
- *Safe, efficient and multimodal transport*
- *Sustainable and climate neutral mobility*
- *Mobility as a Service solutions*
- *Data access, data management and data sharing solutions*

Timeline

Preliminary schedule - Saxony

Launch of the call	19 May
Project submission <i>-1. level</i>	19 May - 19 July
Evaluation period <i>-2. level</i>	20 July - 29 November
Results' announcement	30 November
Obligatory start of projects	January - February 2024
Project length	Max. 24 months

Who

Eligible applicants Saxony

- **Saxon SME -mandatory**
- Research organisations in Saxony
- Universities / universities of applied sciences in Saxony
- Other enterprises in Saxony
- **Eligible Saxon applicants** must be in compliance with ERDF/JTF Technology Funding scheme 2021-2027
- **+ at least one eligible applicant on the Czech side**

How

Submission process -Saxony

- submission and funding process manage by the SAB –Sächsische Aufbaubank -Förderbank- www.sab.sachsen.de
- Two level submission following the ERDF/JTF Technology Funding regulation for joint R&D Projects
- **1. level:** a project outline and the common proposal–in English- have to be submit online at the SAB website -funding portal -*Förderportal* until the deadline stated in the call **-19. July!**
 - Please check the SAB website for additional documents you need to submit!
- **2. level:** SAB will ask the saxon applicants to submit the full proposal
 - For question during submission process contact the SAB
- Czech partner of the consortium applies on Czech side, **however both applications on both sides must be approved to receive funding!**

Funding intensity

- Expected amount for saxon applicants allocated to the call: 5 milion Euro
- Funding intensity depends on the type of applicant and type of research
 - Basic funding: 20% experimental development or 45% industrial research
 - Extras: 10% for medium-sized or 20% for small-sized enterprises, 15% for joint projects, 5% for projects in this call
 - For saxon SME maxium funding: 80%
- 90% funding for saxon research Institutions, universities and universities of applied sciences
 - saxon company or a consortium of companies must account for at least 50 % of the eligible project costs on the Saxon side
- **Saxon funding follows regulations of ERDF/JTF Technology Funding scheme 2021-2027**
